At GMAC, we respect your privacy. We are pleased to inform you of your privacy rights and how GMAC will treat your personal information. When your application is received, we will establish a file on you in which we will retain personal information about you that we collect as described below. This information will be used and retained for the following purposes: (1) to evaluate your credit and employment history and to properly administer your account should you execute a contract for purchase or lease if such contract is assigned to us; (2) to assist in any collection activity on such account; if necessary; (3) to determine the suitability of and your eligibility for our products and services; (4) to provide you with ongoing service under any contracts you may enter into with us or our affiliates; (5) to offer you products and services that we determine are best-suited to your needs and preferences; and (6) to meet legal and regulatory requirements.

We will consult a credit reporting agency to determine the suitability of your application. In addition, we may, from time to time, during the course of our financial relationship with you, collect personal information about you from credit reporting agencies, credit bureaus and others.

Only GMAC employees and service providers whose job functions include customer service, credit evaluation, collection of accounts and customer program development and implementation will have access to the information contained in your file during the time it is maintained by us.
